## Notes on Speakers

**COIT BLACKER** is Special Assistant to the President and Senior Director for Russia, Ukraine and Eurasia at the National Security Council. He has the lead responsibility in the White House for advising the President and the National Security Advisor on all aspects of US relations with the states of the former Soviet Union (excluding the Baltic states). He also serves as vice chairman of the Administration's principal interagency policy development group on Russia, Ukraine and the newly independent states. Mr. Blacker's areas of expertise include the foreign and military policies of the Soviet successor states, international and regional security issues, and nuclear arms control. He is the author of numerous articles and seven books and monographs on these subjects, including *Hostage to Revolution: Gorbachev and Soviet Security Policy 1985-91*. Prior to his appointment at the NSC, Mr. Blacker was deputy director and senior fellow at the Institute for International Studies and co-director of International Relations and International Policy Studies Programs at Stanford. He received his undergraduate degree from Occidental College and his master's and doctorate degrees from the Fletcher School of Law and Diplomacy at Tufts University. He is a member of the Council on Foreign Relations (New York), the International Institute for Strategic Studies (London), and the Center for International Security and Arms Control (Stanford University).

**GRETA BULL** is a senior program officer at the Eurasia Foundation in Washington, DC. Prior to moving to Washington in April 1995, Ms. Bull worked in Kyiv for four years, where she established the Eurasia Foundation's field office for Ukraine, Belarus and Moldova. Ms. Bull was a World Bank MacNamara Fellow in 1992-1993 and is the published author of two reports on firm-level trading behavior of Ukrainian enterprises. Prior to her fellowship with the World Bank, Ms. Bull was instrumental in establishing the Kyiv office of Harvard University's Project on Economic Reform in Ukraine (PERU). Ms. Bull received her Bachelor's degree from the University of Washington and holds a Master's degree in Public Policy from Harvard University's John F. Kennedy School of Government.

**GEOFFREY COWAN** has been the Director of the Voice of America since March 1994. He is the VOA's 19th director; his father, Louis G. Cowan, was the 2nd director, during World War II. VOA is the radio arm of the U.S. Information Agency, broadcasting 1,000 hours of programming in 47 languages, to an estimated weekly audi-

ence of more than 100 million. Mr. Cowan has worked in almost every facet of communications—as a public interest lawyer, best-selling author and award-winning teacher, playwright, producer and government official. For the past 20 years he has taught communications law and policy at UCLA. Mr. Cowan is the author of *People v. Clarence Darrow: The Bribery Trial of America's Greatest Lawyer*. As a member of the Board of Directors of the Corporation for Public Broadcasting in the early 1980s, he played a key role in the development of National Public Radio. Mr. Cowan is a graduate of Harvard College and Yale Law School.

**TAMARA GALLO** is Director of the Ukrainian National Information Service (UNIS), the Washington D.C. public affairs office of the Ukrainian Congress Committee of America (UCCA). As the voice of the Ukrainian-American community in the nation's capital, the responsibilities of the director include conducting research and planning for the UCCA's political strategies, informing the U.S. Government, policy makers, the academic community, and the media on current developments in Ukraine and issues of importance to Ukraine and the Ukrainian-American community; hosting and organizing schedules for visiting Ukrainian dignitaries; and disseminating relevant information to the Ukrainian-American community. She also serves as project director of the Mass Media Civic Education Program, funded by the Eurasia Foundation, which promotes the support for market-oriented economic reform through television documentaries. In 1994, Ms. Gallo worked in Ukraine, conducting a comprehensive civic education project for Ukraine's general elections.

**ROMAN A. GOY**, Senior Vice President for Medical Affairs of Coastal Physicians Services, is on the Board of Directors of the Ukrainian Medical Association of North America and is President of the Baltimore-Washington Chapter of UMANA. Dr. Goy received his Medical Doctor degree from the University of Valencia and an MBA degree from Loyola College. He has been president of the Maryland Chapter of the American College of Emergency Physicians and has taught advanced pediatric life support and emergency medicine at Johns Hopkins Hospital; he was chairman of the Department of Emergency Medicine at Fallston General Hospital.

**ORYSIA HEWKA** has been actively involved in the Ukrainian Educational and Cultural Center of Philadelphia since its founding 15 years ago and has served as its

executive director for more than 10 years. With 10 employees, the UECC conducts a busy schedule of activities for the Delaware Valley Ukrainian-American community, which numbers more than 70,000. At the Center, she has initiated a new program, assisting refugees and immigrants from Ukraine and other Eastern European countries. Mrs. Hewka has been active in human rights work on behalf of Ukrainian dissidents for more than 15 years.

**YURIJ HOLOWINSKY**, TWG Board Member-at-large, is a self-employed independent contractor pursuing business development in Ukraine. He also works as a diplomatic interpreter in Ukrainian for the Department of State and is an officer the active US Air Force Reserve.

**IRENE JAROSEWICH** returned this summer to Washington after working in Ukraine for more than four years in government and media relations. In March 1991, Ms. Jarosewich traveled to Lviv and Kyiv as a co-organizer of a two-week press tour that brought more than 70 American, Canadian and European journalists to Ukraine. She returned to Kyiv later that Spring and for 18 months worked in the Rukh Information Office. After leaving Rukh, Ms. Jarosewich consulted for several U.S. firms doing business in Ukraine. Most recently, she was director of public relations for UTEL, a long-distance telecommunications joint venture between AT&T, Deutsche Telecom, PTT Netherlands and the Government of Ukraine. Ms. Jarosewich has been a member of TWG since its founding in 1984, and between 1989 and 1981 was editor of TWG News.

**OREST A. JEJNA** is President of the Ukrainian American Bar Association. He also serves as Secretary/Treasurer of the International Committee of the Arizona State Bar, member of the World Congress of Ukrainian Lawyers, and as International Committee Member of the Arizona Chamber of Commerce. Mr. Jejna practices law in Phoenix; is owner and founder of Jemar International, which acts as consultant and agent for firms doing business in Ukraine. His efforts on behalf of human rights have been recognized by the Americans for Human Rights in Ukraine, the Phoenix Jaycees and the Community Relations Council of the Jewish Federation of Greater Phoenix. He received his JD degree from the University of Puget Sound School of Law in 1979.

**ADRIAN KARATNYCKY** is president of Freedom House, a non-partisan, non-profit organization that promotes democracy, civil society and the rule of law, and monitors human rights, political rights and civil liberties around the

world. He coordinates *Freedom in the World*, the organization's annual survey of political and civil rights. From 1984 to 1993, Mr. Karatnycky served in various important positions with the AFL-CIO—as assistant to the president, as research director in the International Affairs Department, and as research director for the AFL-CIO's Free Trade Institute, supervising assistance programs to *Solidarnosc* in Poland as well as to democratic trade unions in Hungary, Bulgaria, the Czech and Slovak republics, Russia and Ukraine. In the early 1980s, he was research director of the A. William Randolph Institute, and, in 1979, assistant director of the International Sakharov Hearings. Mr. Karatnycky has authored three books on recent developments in Eastern Europe and the Soviet Union—*Workers' Rights, East and West* (with Adolph Sturthal), *The Hidden Nations: The People Challenge the Soviet Union* (with Nadia Diuk) and *New Nations Rising: The Fall of the Soviets and the Challenge of Independence*. He is a frequent contributor of articles to leading U.S. newspapers and journals and is regularly interviewed on CNN, the *MacNeil-Lehrer Newshour* and NPR.

**KEVIN KLOSE** is Director of Radio Liberty, a U.S. Government-funded radio station which broadcasts in 13 languages to an estimated daily audience of 18 million people living in the now independent countries of the former Soviet Union. Prior to that, he spent most of his journalistic career as correspondent and editor with the Washington Post. He was Moscow Bureau Chief from 1977 to 1981, after which he wrote the award-winning book *Russia and the Russians; Inside the Closed Society*. Later, he served as the Post's national security editor and as editor of its Outlook section. His wife, Eliza Kellog Klose, is executive director of ISAR, a Washington organization that has pioneered in providing aid and technical assistance to citizen environmental activists in the former USSR. Born in Canada, Mr. Klose grew up in New York State and is a graduate of Harvard University.

**MICHAEL KOSTIUK** is Vice President of the Ukrainian Canadian Professional and Business Association of Ottawa and Vice President for Communications of the Ukrainian Canadian Professional and Business Federation. By profession, Mr. Kostiuk is a geographer who also works as an INTERNET consultant does volunteer work for the Canada-Ukraine Partner's Program.

**NADIA KOMARNYCKY-MCCONNELL** is President of the U.S.-Ukraine Foundation. She directs the development and implementation of projects, oversees administrative issues, and represents the Foundation as an expert in

Ukrainian affairs. Prior to founding the foundation, she was the president of NKM Associates, a government relations and public affairs firm. Before that, she held several positions in government, including Deputy Assistant Administrator for Legislative Affairs for NASA and Director of Congressional Relations for FEMA. In the private sector, Mrs. McConnell was Government Relations and Public Affairs Director for the Arizona Multi-Housing Association, Director of Training for the Hecht Company, and Director of Personnel for Arcoa. Mrs. McConnell has made 11 trips to Ukraine over the past three years to conduct on-site assessments and to manage other programs of the U.S.-Ukraine Foundation. She has spent her 30-year professional career, 10 of it in government service, creating and implementing programs—both commercial and institutional—that utilize effective communications and facilitate policy development.

**JANE KUNKA** has been serving in the Public Affairs Office of the Federal Communications Commission (FCC) since January, 1993. Prior to this current assignment, she was on the personal staff of former FCC Chairman Alfred C. Sikes. Before assuming her positions at the FCC, Ms. Kunka worked on Capitol Hill and served on the personal staff of (Retired) Congressman Matthew J. Rinaldo (R-NJ) for two years. Before coming to Washington, she was employed by the Kimberly-Clark Corporation in New Jersey. Born and raised in Northern New Jersey, she is a second generation Ukrainian-American, whose ancestors immigrated from Ukraine and Eastern Europe to New York in the early 1900's. She is a graduate of Caldwell College, Caldwell, New Jersey, with a degree in Business Administration. She is also a graduate of Averett College, Danville, Virginia, where she earned her MBA. In other professional activities, Ms. Kunka chairs the Telecommunications Task Force for Women in Government Relations in Washington, D.C., and is the Public Relations Director for The Washington Group.

**ASKOLD S. LOZYNSKYJ** is President of the Ukrainian Congress Committee of America, an umbrella organization for Ukrainian Americans. He has traveled numerous times to Ukraine in various capacities, primarily as an advisor on democratic and free-market processes. He frequently represents the Ukrainian community in meetings with U.S. and Ukrainian government officials, including President Leonid Kuchma, President Bill Clinton and Vice-President Al Gore, officials of the National Security Council, the Department of State, USAID, and members of Congress. He is a past board member of CARE International; his many Ukraine-related affiliations include membership on

the Executive Board of the Kyiv-based World Ukrainian Coordinating Council, the Toronto-based World Congress of Ukrainians, and other numerous Ukrainian organizations. He is also a member of the American Bar Association and the Ukrainian American Bar Association. He received his JD degree from Fordham University in 1976, and was admitted to the bar of the State of New York in 1977. Mr. Lozynskyj specializes in real property, commercial law and estates.

**ANDREW MASIUK** is the Director General of the International Management Institute in Kyiv (IMI-Kyiv). He became Director General in 1992; he had worked at IMI-Kyiv since its inception in 1989. The International Management Institute in Kyiv is the oldest business school in Ukraine. It has awarded 215 MBA degrees and is licensed by the Ukrainian Ministry of Education. Its graduates are prominent in both business and government with Deputy Prime Minister Roman Shpeck the most notable example. IMI-Kyiv and the School of Industrial Administration of Carnegie Mellon University have been awarded a partnership grant by USAID. This partnership will facilitate the expansion of IMI's programs, particularly such programs that will help the newly privatized industry in Ukraine. The partnership envisions faculty exchanges and will contribute to the growing awareness of Ukraine among business persons in the United States. Mr. Masiuk held faculty positions at Simmons College (Boston), West Chester State University (West Chester, PA) and the International Institute for Management Development (Lausanne, Switzerland). In addition to academic experience, Mr. Masiuk has worked as a manager for Digital Equipment Corporation. Mr. Masiuk has a bachelors degree from LaSalle University, a Masters degree in social service from Bryn Mawr College, and an MBA from the Wharton School of the University of Pennsylvania.

**GEORGE MASIUK** is the President of The Washington Group. He has been active in TWG since its inception, helping to plan and organize previous TWG Leadership Conferences. Mr. Masiuk is a communications engineer currently working on the modernization of the National Airspace System. He holds a B.S.S.E. from the University of Pennsylvania and a M.S.E.E. degree from George Washington University.

**RICHARD MURPHY** is a Senior Associate at the Center for Strategic and International Studies in Washington, DC. He manages its Ukraine project, the centerpiece of which is the American-Ukrainian Advisory Committee (AUAC). The AUAC is a group of about 20 prominent Americans



and Ukrainians including: Zbigniew Brzezinski, Henry Kissinger, Frank Carlucci, General John Galvin, Malcolm Forbes, Jr., George Soros, and Westinghouse CEO Michael Jordan along with Roman Shpek, Borys Tarasiuk, Viktor Pynzenyk, Wolodymyr Hrynyov and General Kostyantyn Morozov. Mr. Murphy has also worked as Legislative Assistant to Senator Hugh Scott (R-PA); Director of Government Relations for Merck & Co., Inc. and Vice President, Legislative Affairs for the National Food Processors Association. A native of New York, he graduated from Yale University with a B.A., in history and earned his M.A. from the Paul H. Nitze School of Advanced International Studies at The Johns Hopkins University.

**BOHDAN PETER REKSHYNSKYJ** is a computer consultant based in Manhattan, New York City. His consultancy provides services to Wall Street financial firms. In addition, services pertaining to Internet are also provided to a wide range of clients, from individuals to large corporations. Mr. Rekshynskyj also is the Project Coordinator for the Ukraine FAQ (Frequently Asked Questions) Plus project which is sponsored by the Sabre Foundation. **OREST SUBTELNY** is Professor of history and political science at York University in Toronto. He is the author of six books, including *Ukraine: A History*, originally published in English and later in Ukrainian (half-million copies sold in Ukraine). Prof. Subtelny received his Ph.D. (the first Ph.D. in Ukrainian studies) from Harvard University and has taught at Harvard University, at Hamilton College and at Tübingen University. He is the editor of several scholarly journals, including *Nationalities Papers*, and is a member of the Ukrainian Academy of Sciences in Kyiv.

**YURI SHCHERBAK** presented his credentials as Ukraine's second ambassador to the United States during President Leonid Kuchma's state visit to Washington in October 1994. Prior to this assignment, he had served as Ukraine's ambassador to Israel (1992-1994) and as minister of environmental protection (1991-1992). A writer and doctor by profession, Dr. Shcherbak began his political career in 1989, when won a seat in the USSR Supreme Soviet. Having never been a member of the Communist Party, he worked closely with the Russian human rights advocate Andrei Sakharov. As chairman of the subcommittee on energy and nuclear safety, he initiated the first

parliamentary investigation of the Chornobyl nuclear accident as well as those in Semipalatinsk and in the Urals. An eyewitness to the 1986 Chornobyl disaster, Dr. Shcherbak exposed the malfeasance before and after the accident in his documentary novel *Chornobyl*. He has also written extensively about the Stalinist man-made famine in Ukraine in 1932-33. In all, he has authored 20 books of poetry, prose, plays and essays. Dr. Shcherbak received his Ph.D. and D.Sc. degree in epidemiology from the Kyiv Medical College. In 1988, he founded and led the Ukrainian Green Movement (which became the Green Party in 1990). He is a member of Ukraine's Academy of Environmental Sciences.

**TIMOTHY BOHDAN TRUSEWYCH** is President of the Ukrainian Medical Association of North America. He is also Medical Director of the AT&T Health Services Group in Naperville, IL. Earlier, after receiving his D.O. degree in 1976 from the Chicago College of Osteopathic Medicine, Dr. Trusewych served on the staff of the Naval National Medical Center in Bethesda, as clinical director and staff internist at the Rush-Anchor HMO, and as associate medical director at AT&T Bell Labs. He is a member of numerous professional organizations.

MELANNE VERVEER is deputy assistant to the President and deputy chief of staff to the First Lady. She served as issues advisor to the Clinton-Gore campaign and as special projects coordinator to Mrs. Clinton during the transition. Before joining the campaign, Ms. Verveer was executive vice president and public policy director for People for the American Way, a constitutional liberties group. Earlier, she worked in a variety of positions on Capitol Hill and in the public interest community. She was legislative director to Rep. Marcy Kaptur (D-Ohio), coordinator for civil rights and urban affairs at the US Catholic Conference and field manager at Common Cause. She also served on the boards of many nonprofit organizations, among them, the Coalition on Human Needs, Leadership Conference on Human Rights, the Advocacy Institute and Public Allies. In 1989, she was named to *Beachman's Guide to Key Lobbyists*. Ms. Verveer received her master's and undergraduate degrees from Georgetown University. Melanne Starinshak Verveer was raised in Shamokin, Pennsylvania, and received her primary and secondary education in Ukrainian Catholic parochial schools. Her maternal and paternal grandparents were born in Ukraine, emigrated to the U.S. at the turn of the century and settled in Pennsylvania. Ms. Verveer accompanied the President and First Lady on their recent visit to Kyiv.
