Soroka, Kysylevych, Lassowsky Shine in Cultural Fund Recital

TWG Cultural Fund recital violinist Solomia Soroka, her accompanists—Myroslava Kysylevych and Oksana Lassowsky—as well as the featured works by composer Myroslav Skoryk received a stellar review from the Washington Post senior music critic Joseph McLellan.

Writing about the February 23 recital at the Chevy Chase Women's Club, the critic noted that until this recital, he had never heard a note composed by Myroslav Skoryk and added that this contemporary Ukrainian composer should be better known.

"He is an original, a composer with a distinct identity, a mastery of many idioms—jazzy, folk-style and moderately avant-garde—that he uses to shape works embodying piquant contrasts, convincing climaxes and sometimes impish wit," Mr. McLellan wrote.

He said Mr. Skoryk's Sonata No. 2 for Violin and Piano, his Burlesque in C for Solo Piano and Spanish Dance for Violin and Piano were the highlights of the program, which featured works by Ukrainian composers—"a sadly neglected group in this country"—but also included such landmarks in the standard repertoire for violin and piano as Giuseppe Tartini's "Devil's Trill" sonata and Pablo de Sarasate's "Zigeunerweisen" ("Gypsy Airs").

The reviewer made a special note of Ms. Soroka's "two talented pianists

Futey gets Presidential Award

Ukrainian President Leonid Kuchma honored Judge **Bohdan A. Futey** of the U.S. Court of Federal Claims for his work in helping Ukraine develop its judicial system.

He presented Judge Futey with the Presidential Meritorious Award (second degree) during his one-day visit in Washington December 8 for talks with the Clinton administration and international financial organizations.

Noting the time and effort Judge Futey has devoted to assisting Ukraine since its independence, President Kuchma called him "a true friend of Ukraine."

It was the second time that Judge Futey was honored for his work in Ukraine. During festivities marking the anniversary of Ukraine's independence in Kyiv in 1995, he received a third-degree Presidential Meritorious Award.

Judge Futey has been involved with democratization and

Christmas party, auction—a fantastic evening

Guests at TWG's 1999 Christmas Party had an unforgettable holiday evening at the Evans Farm Inn—with its traditional Christmas decorations, a glowing fire in the fireplace and its signature country-style food. They heard a memorable performance by virtuoso bandurist and com-

poser Roman Hrynkiw from Kyiv, and, if that wasn't enough, many walked away with some amazing bargains at the TWG Cultural Fund's first silent auction.

The party and auction were held on Friday, December 18, a few days before the historic inn in McLean, Virginia, was closed forever, giving way to more suburban development.

In many instances the auction participants paid only 25% to 50% of the fair market value for such items as two tickets to The Washington Opera's performance of *Julius Caesar*, four tickets to a performance sponsored by the Washington Performing Arts Society featuring cellist Yo-Yo Ma, an oil painting by Ukrainian artist Boreyko, dinner for 10 at the Marrakesh Restaurant, a series of 8 fencing lessons, a photo signed by the Prime Crew of the Third Manned Skylab Mission in 1974, and much, much more.

The 87 items available for bidding included paintings, etchings, and photographs; a large inlaid bulava, a pysanka, and other folk art; jewelry; a week's stay at a vacation home in Deep Creek Lake; lunch and a boat ride in Annapolis; dinner in Kyiv; a two-hour architectural consultation, preparation and filing of an individual income tax return, and other professional services; books and note cards; CDs, videos, and historic Ukrainian recordings; 2 dozen varenyky; and gift baskets.

The guests were informed when 30 minutes remained before the close of the auction and, with 10 seconds left, everyone joined in the final countdown. The items that generated the most bids—some higher than the fair market Cultural Fund Auction Chairperson Daria Stec introducing bandurist Roman Hrynkiw during the TWG Christmas party and silent auction.

value—were wooden inlaid objects from Ukraine, liquor, jewelry, and gift certificates to restaurants.

Thanks to the many generous donors of items and bidders, the auction netted over \$3,000 to support the activities of the Cultural Fund.

To be eligible for the two-month internship, candidates should have completed at least two years of undergraduate studies and be proficient in English and Ukrainian. (An excellent command of English—native or near-native fluency—is required). Applicants should possess excellent oral and written communication skills and be able to demonstrate excellent computer skills, including proficiency with the Internet. Candidates should anticipate assisting the embassy with whatever issues and tasks that may arise, including general conventional Fantasy No. 2 on Ukrainian themes."

"Her tone is warm and mellow on the low strings," he said, "brilliant on the high strings, perfectly controlled and expressively used."

The recital was sponsored jointly by the Cultural Fund and the Embassy of Ukraine, which featured the performers in a separate program at the Embassy on the following day.

Fulbright scholarships in Ukraine

Approximately five Department of State Fulbright U.S. Graduate Student Grants will be available to Ukraine for the 2000-2001 academic year. A special competition for these awards, with an April 7, 2000, application deadline, is currently being held.

The competition is open to all fields of study for ten-month awards. Preference will be given to graduating seniors, Master's candidates, those enrolled in Ph.D. programs, but not yet admitted to candidacy, young professionals and young artists.

Language proficiency commensurate with the purposes of the Fulbright Program and sufficient to carry out the proposed course of study or research is expected at the time of application.

Applicants will be required to file a formal Fulbright Grants for

Graduate Study and Research Abroad application. Students currently enrolled in a U.S. college or university should contact their on-campus Fulbright Program Adviser for further information and applications. Applicants not currently enrolled in a U.S. college or university should contact IIE's U.S. Student Programs Division in New York at 212-984-5330 or one of its regional centers in Chicago, Denver, Houston or San Francisco for further information and application forms.

Kennam Institute Short-term Grants

The Kennan Institute offers Short-term Grants (\$100 per day for up to one month's duration) to scholars whose research in the social sciences or humanities focuses on the former Soviet Union, and who demonstrate a particular need to utilize the library, archival, and other specialized resources of the Washington, D.C., area. Academic participants must either possess a doctoral degree or be doctoral candidates who have nearly completed their dissertations. For non-academics, an equivalent degree of professional achievement is expected. There is no official application form for short-term grants.
