## TWG Leadership Conference '99

*Part of multi-organizational  
Ukrainian-American parley*

This year, The Washington Group (TWG) will hold its popular Leadership Conference June 25 - 27 in Washington in conjunction with the conferences of five other organizations.

The Joint Conferences of Ukrainian American Organizations will include concurrent conferences of the Ukrainian Medical Association of North America (UMANA), Ukrainian American Bar Association (UABA), Ukrainian National Credit Union Association, Ukrainian Engineers Association of America, and Ukrainian Library Association of America. Many other organizations across the country are also participating to make this a major event in our community.

Nearly eight years after independence, Ukraine stands at the thresh-

old of a new millennium. Will it develop as a politically stable and economically vibrant democracy with a Euro-Atlantic orientation? The question of Ukraine's direction has not been resolved. Anti-reform forces who look towards a Slavic union remain strong. What role will America, including the Ukrainian-American community, play in facilitating positive change in Ukraine?

TWG's conference—"At the Threshold"—will be held on June 25-27 at the Hyatt Regency Crystal City Hotel in Arlington, VA. TWG conference sessions will examine specific subjects within the overall political, strategic, humanitarian,

As 1998 came to a close, some TWG members took over the helm of two major Ukrainian-American institutions: **Oleksa Bilaniuk**, of Wallingford, PA, was elected president of the Ukrainian Academy of Arts and Sciences in the U.S. (known by the Ukrainian acronym "UV AN"); **Ihor Gawdiak**, of Silver Spring, MD, was elected president of the Ukrainian American Coordinating Committee; and former TWG News editor **Ross Chomiak** took over Mr. Gawdiak's previous UACC position of Washington Office executive director.

**Nadia Diuk** has been elected a member of the prestigious Council on Foreign Relations. She is senior program officer for Central and Eastern Europe and the New Independent States at the National Endowment for Democracy, and co-author of the book *New Nations Rising: the Fall of the Soviets and the Challenge of Independence*.

**David Marples**, TWG Honorary Member and professor of history at the University of Alberta, was awarded a McCalla Research Professorship 1998-99 by the University of Alberta. In October 1998 he was also awarded the Shevchenko Gold Medal for his work on Ukraine by the Central Congress of Ukrainians in Canada (Ukrainian Canadian Committee) in Winnipeg. He has recently published *Nuclear Energy and Security in the Former Soviet Union* (Westview Press, 1997), a book co-edited with Marilyn J. Young of Florida State University, and is the author of a new book, *Belarus: A Denationalized Nation* (Amsterdam: Harwood Academic (See *Notes*, page 7)

# TWG seeking summer intern for Ukrainian Embassy

The Washington Group, in cooperation with the Embassy of Ukraine, is seeking candidates to participate in a two-month summer internship at the Ukrainian Embassy in Washington, D.C.

The purpose of the project, which is being conducted under the auspices of the TWG Fellowship Committee, is to provide the Ukrainian Embassy with an intern who could serve as a research assistant to the embassy staff. In turn, the intern would gain valuable experience in learning how a foreign embassy in Washington works and how the embassy interacts with various Washington individuals and institutions.

TWG has previously funded three internships at the Embassy of Ukraine. Helena Zyblikewycz, a student at Georgetown University, served as a summer intern in 1996. Alexandra Richardson, a student at Marquette University, worked in the Ukrainian Embassy in 1997. Most recently, Taras Seryy, a student at John Carroll University in Cleveland, completed the two-month internship in summer 1998.

Candidates for the 1999 internship should:

- 1.) have completed at least two years of undergraduate studies;
- 2.) be proficient in English and Ukrainian (an excellent command of English—native or near-native fluency—is especially important);
- 3.) possess excellent oral and written communication skills;
- 4.) be able to demonstrate excellent computer skills, including the Internet;
- 5.) anticipate assisting the embassy with whatever issues and needs should arise, including general office work;
- 6.) submit a one-page essay explaining their interest in the internship, when they would be available to participate in the project, and how their work, educational and personal experience would help meet the goals

of the project;

7.) submit copies of academic transcripts, and one letter of recommendation, and provide two references;

To be considered for this internship, candidates must submit this information to TWG no later than April 21, 1999.

The Fellowship Committee will provide the successful candidate with a stipend of \$1,500.

## *TWG member appeals for more aid for orphans in Ukraine*

The Orphans' Aid Society for Ukraine has worked for more than seven years to aid orphaned children in Ukraine. Its work is enabled by the orphans' sponsors, and by all people of good will who know that these children are a new nation's most important resource. These sponsors are truly the builders of Ukraine's future. They support the country morally and materially by helping the children who need it most, especially in these trying times of hardship.

At the present time, the Society manages the sponsorship of more than 1,000 orphans in Ukraine who are living either with their grandparents, distant relatives, or sometimes even with strangers. As we all know, the state of the Ukrainian economy is deteriorating steadily. A typical middle-aged adult is hard-pressed to support his or her children or to help his or her elderly parents. This situation is a long-term problem, without any improvement in sight, and has led to a higher than normal suicide rate. Combined with a decreased life expectancy, conditions in Ukraine have left many suffering children without any family support.

Many Ukrainian policemen, soldiers, and people in other protective services have lost their lives while performing their duties in helping to build a strong and independent Ukraine, among them Ukrainian soldiers who died performing their United Nations duties helping stabilize war-ravaged Bosnia. Many were parents who left their children behind without

provisions for their sustenance.

The consequence of these tragic events and conditions in Ukraine is that the Society now has more than 600 applications from newly orphaned children seeking support or some kind of assistance. In addition to being orphans, many are ill, and they need help desperately.

For only \$15.00 per month, sponsors can make a difference, perhaps the most important difference, in a child's life.

Upon choosing a child to sponsor, you will receive the child's picture, address, and information about his or her living conditions. The child is required to write a personal letter to you. Most of the Society's sponsors write back to their sponsored children, and many personal relationships have been crafted in this fashion. Translation of letters is available if needed.

The Orphans' Aid Society for Ukraine is a registered charity with the U.S. Internal Revenue Service, and all donations are tax-deductible. Administrative costs are amazingly low: less than 2% of revenues. These costs are kept so low because all Society personnel work on a volunteer basis, and most expenses are covered from personal funds, not from donations.

economic, and technical environment in Ukraine, with a focus on the U.S.-Ukrainian relationship. The five sessions are:

- Ukraine on the Eve of Presidential Elections;
- U.S.-Ukraine Military Cooperation;
- Trafficking of Women from Ukraine (jointly with Washington/Baltimore Chapter of the Ukrainian National Women's League of America);
- Ukraine's Role in International Space Programs (together with the Ukrainian Engineers Association);
- U.S.-Ukraine: Business, Trade and Investment (together with the UABA).

These five sessions will be held on Saturday, June 26 and Sunday, June 27. Panels will include experts from government, academia, business, and non-governmental organizations. Among them are Ukrainian Americans who have worked on collaborative projects with Ukraine in these areas.

TWG Conference attendees are encouraged to participate in Joint Conference events, including a Congressional reception on Thursday, June 24, an evening reception at the State Department (in the elegant Diplomatic reception room where ambassadors are sworn in and heads of state are hosted) on Friday, June 25, a TWG-organized luncheon on Saturday, June 26, the Gala Banquet and Ball on Saturday evening featuring two bands and a special guest speaker, and a Brunch and Cultural Event on Sunday, June 27.
